

LEGACY GUIDE

Your gift could make a difference in hundreds of lives.

How to leave a legacy to the Go & Save Ministries?

1. Decide on the type of legacy you would like to leave. See below for the two most common types and some suggested wording. Decide which is best for you and then either the amount or the percentage you would like to gift to Go and Save Ministries.
2. Arrange a meeting with your solicitor. If you wish to leave money to Go and Save Ministries, you will need to provide your solicitor with the basic information about Go and Save Ministries. 3. Visit your solicitor. If you are writing your Will for the first time, take along this leaflet with the suggested wording; however, your solicitor Will draw it up accordingly. If you have already written a Will and would like to add a legacy to the Go and Save Ministries into this, please ask your solicitor to help you write the Will as example text below.
4. Complete the response form below. We take seriously the trust placed in us by those who leave a legacy gift to the Go and Save Ministries. We aim to plan for the future and steward wisely the gifts we receive, and it can help our planning enormously if we know of your intention to leave funds to the Go and Save Ministries in advance.

What percentage of my donation will go directly to the people it needs to go to?

We are a registered charity with the Charity Commission. We do not pay any of the trustees any wages or rent on office space.

We are blessed with a good team of believers who do what needs to be done for the love of Christ free of charge or pay their way rather than burden the charity. It is safe to say more than 90% of the donations go directly to the people or the project.

This means more than 90% of all money donated goes directly to mission projects.

A guide to types of legacy

There are two main types of legacy you can consider:

A residuary legacy is a gift from the residue of the estate, often expressed as a percentage share after all other gifts and payments have been made.

A pecuniary legacy is a gift of a specific amount of money.

For a RESIDUARY Legacy, we suggest the following wording:

“I give _____% of the residue of my estate to Go and Save Ministries, Registered Charity number 1195671 of 22 Langley Drive, Crawley, West Sussex RH11 7SY, for its charitable purposes. I further direct that the receipt of the treasurer or other proper officer of Go and Save Ministries, for the time being, shall be a full and final sufficient discharge for the said legacy”.

For a PECUNIARY Legacy, we suggest the following wording:

“I give to Go and Save Ministries, Registered Charity number 1195671, of 22 Langley Drive, Crawley, West Sussex RH11 7SY, the sum of £_____ for its charitable purposes. I further direct that the receipt of the treasurer or other proper officer of Go and Save Ministries, for the time being, shall be a full and final sufficient discharge for the said legacy”.
